

The regular meeting of the Eldred Township Supervisors was called to order by the Chairman Kenny Bower Sr. at 7:00 p.m. on March 17, 2016 at the Eldred Township Fire Company building. Supervisors Mark Ranck, and Cody Hoover were also present. Following the motion of Mark Ranck and the second of Cody Hoover the minutes of the 03/02/2016 township meeting and the 3/17/2016 bill list were approved as presented; no objections or corrections were noted.

Old Business:

- A. Cinder Shed Roof – Tammy to call Steve Strange again to follow up.
- B. FEMA Flood maps – Denise Dieter was to attend a Floodplain workshop; we have not yet received her report.
- C. Codification – Nothing new to report.
- D. Resolution 3.17.16 Hazard Mitigation Plan Update – The board resolved to approve the update following the motion of Mark Ranck and the second of Cody Hoover unanimously.
- E. 2016 lawn mowing – accepting proposals till first meeting in April.
- F. Larson Design Proposal – Tabled, Board is reviewing and will look at it further during upcoming road inspection.
- G. Worker’s Comp Policy – Tabled, Board is reviewing.

New Business:

- A. Excess Maintenance Agreement – Request from Tom McCracken to use Mosteller Road to remove loads of logs from the Wentzler property. The Township has stopped him from hauling until the proper documents, bonds and insurance have been provided to the township.

Reports

Solicitor: Not present

Road Master: Mark reported that the plows have been taken off and stacked in the smaller garage. Some of the spreaders have been removed and cleaned and lubricated. The bermer has been installed. The tiger has been gone over and is running. Mark reported a need for more lighting in the big building and inquired if Scott Wheeland could work on that. The Board agreed unanimously to have Scott install additional lighting. Kenny reported that he ordered a new weed eater from Waltz’s \$470.00. It was also discussed to look into a new chainsaw. The ones the township have do not run and John Harvey was present and said they have not run for years and that he always used his own.

Zoning: Zoning hearing is scheduled for Mark and Paula Shuman for garage setbacks, to be held April 5th at 7:00pm. Tammy to follow up again with Code Inspections re: the internet tower on the Bennett property.

Planning: No report

Fire Co: Rider Park Open House June 5th, 2016 Chuck is requesting assistance with this event from others. The committee is still reviewing options for a new ambulance.

EMA: Nothing new to report.

SEO: No report

Public Comments: Bruce Stuart – reported that the new light poles are on the township right of way on Bruchlacher Rd. Kenny will follow up.

Supervisors: Cody Hoover reported that he went and looked at the salt shed and has some ideas about getting the equipment moved from being stored in there. Kenny Bower reported that he spoke to land owner Oscar Schon who would talk to Chris Ulmer who farms the ground along Bruchlacher and Ridge Top Rd to leave a strip of grass along the township road to help with water runoff.

Other Business: Tammy announced there is a vacancy on the zoning hearing board if any township resident is interested. Terry Knittle is now retired and is not always available. With no further business to come before the board the meeting was adjourned at 7:42 following the motion of Cody Hoover and the second of Mark Ranck, all were in favor.
